Wamego is proud of its long running 4<sup>th</sup> of July celebration known as Celebrate Freedom in Wamego. Again this year we will be offering our visitors more food options during Celebrate Freedom in Wamego. This day-long celebration will offer a “food court” along the parade route in the 500 Block of Lincoln. The food court hours are 4-9 pm. A variety of food trucks/stands will be aligned inside a privately-owned parking lot between the Friendly Cooker and Iimagemakers (the Bittmann Mercantile building) on the East side of Lincoln. Trucks or Tents are encouraged as there is minimal parking for pick-ups. Wamego swells to over 40,000 people on this special day. Your complete menu, with prices, is to be included with the application. You must be willing to delete some menu items in order to be included. We are seeking a variety of foods and will limit the number of “like” vendors. Vendors will be evaluated on a first come, first served basis. Due to the limited number of spaces available the application process is very competitive, and not all vendors that apply will be approved. All decisions made by the committee are final, and inclusion because of previous events’ acceptance is not guaranteed. It is to your benefit to provide as much information as possible; i.e., menu, trailer layout, complete application, pictures, etc., which impacts the acceptance. No applications will be considered without payment.

We are seeking a variety of foods to satisfy our guests on a hot summer day! Please apply early. Confirmation letters will be sent as applications are received and reviewed, starting in late April. Fees for spaces are explained in the attached guidelines and application. Once again, please read all the information carefully, but do not hesitate to call if you have questions.

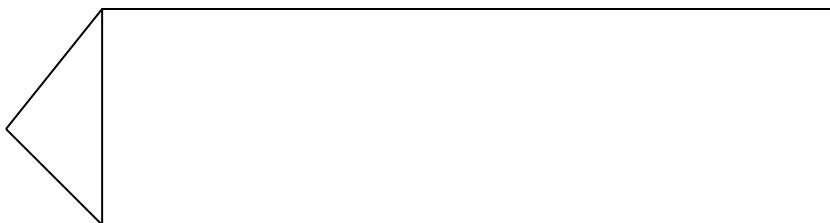

- ❖ Menu Prices **MUST** be provided with this application on a separate sheet.
- ❖ Full- line meals are not to compete with local restaurants – the committee will review menus so as not to have overlapping items with other vendors and local restaurants. You **MAY NOT** be allowed to serve all items on your menu!
- ❖ Copy of your **CURRENT** health license must be included with this application. Expect a possible visit by the State health inspector.
- ❖ Booth fees must be sent with application! We will **NOT** accept applications by fax or without payment.
- ❖ Acceptance as a Food Vendor is not guaranteed. A written confirmation letter is sent if approved.
- ❖ All food must be served from the tent or trailer. No additional serving tables will be allowed.
